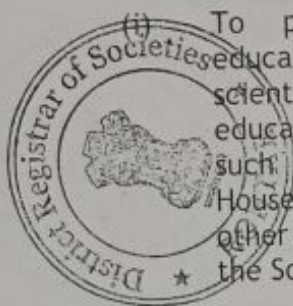

4. Aims and Objects of the Society

- (i) For the benefits of the region and development of People's physical mentally growth by conducting of Games and Sports, Young's

(ii) To settle personal dispute of people in peaceful manner.

- (iii) For social evils like dowry, drug addition alcoholism, smoking, minor marriages illiteracy by awarness programme and movements on over expenditure on marriage.

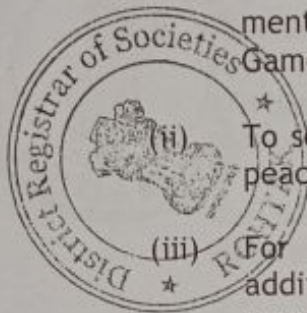
- (iv) To set up voluntary organization in rural and urban areas.
